4. Bookings cancelled less than six weeks before date arrival must pay full balance.
5. Reservations run from 3pm on the day of arrival to 10.00am on the day of departure.
6. **The Pool:** All children and non-swimmers must be supervised in and around the pool building by a responsible adult. The owners regret they cannot be held responsible for any accident that may occur. Visitors are required to sign a form on arrival stating they have read the pool rules before being allowed to use this facility. If the rules are broken owners have the right to ban all members of your party using this facility.
